
Cash, Certified Check, Money Order, Airscribe, Western Union or Direct Pay must be received in our office on or before the above noted dates or the offer will be considered null and void.

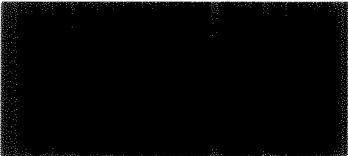
